Public Prosecutors Grade-II) and Senior Assistant Public Prosecutor (Asst. Public Prosecutors Grade-I), Legal Officers of Anti-Corruption Bureau.
- 4. Government have accepted the above recommendations and hereby order that the Office Allowance and Maintenance Allowance shall be sanctioned to the various officers listed below at the rates shown against each.
