In partial modification of the orders issued in the G.O's 3rd & 4th read above, Government hereby enhance the ceiling limit for the sanction of Medical Reimbursement Claims for the treatment taken as Out Patient (O.P treatment), from Rs.10,000/- to Rs.25,000/-, in respect of the All India Service Officers borne in the cadre of AP Serving Officers as well as Pensioners.

2. All the Heads of Secretariat Department concerned (i.e., the Special Chief Secretary to Government / Principal Secretary to Government / Secretary to Government / District Collectors of the concerned / DGP, AP, Hyderabad / PCCF, AP, Hyderabad are authorized to sanction the medical reimbursement claims for the treatment taken as out patient (O.P treatment) upto an extent of Rs.25,000/- in respect of All India Service Officers borne in the cadre of AP and working in connection with the affairs of the State and their dependents & AP Cadre AIS Pensioners, their dependents and AIS Family Pensioners.

3. All the other orders which were issued in G.O's 3rd & 4th read above shall remain as it is.

4. This order issues with the concurrence of Finance Department vide their U.O.No. 5280/85/ A1 /Expr.M&H.I/14, dated 01.3.2014.
